Tour of Nebraska National Guard Facilities

Five of six voting members of the Commission on Military and Veteran Affairs constituted a quorum of the Commission. Tour participants received an update briefing from Maj Gen Bohac regarding the structure, locations, facilities and operational capabilities of the Nebraska National Guard. This briefing included an assessment of readiness centers across the State and of the Bellevue (Offutt) Readiness Center in particular. Participants traveled via one UH-72A Lakota helicopter and one UH-60 Blackhawk helicopter to aerially observe the Nebraska National Guard

Best Warrior competition at the Greenlief Training Site near Hastings Nebraska. Of note, three service members from the Czech Republic Armed Forces competed in this event. Participants received a briefing and a tour from leaders at the Grand Island Readiness Center and Army Aviation Facility Two. The tour continued with a flyover of the Mead Training Site prior to returning to Lincoln.

Hilgert noted that there was no difference in the training, standards, or proficiency between National Guard service members and active duty service members. Given the level of integration today, Hilgert noted that veterans' benefits may need to be similarly integrated with the elimination of legacy seams between benefits for National Guard service as compared to active duty service.

The tour ended at the Nebraska National Guard Joint Force Headquarters Building, 2433 NW 24th St, Lincoln, NE 68524 on Friday, April 13th around 2:00 p.m.
