











# 2014 Nebraska Veterans' Legislation

# Introduction

This guide is offered by the Nebraska Department of Veterans' Affairs as a general overview of military and veterans' legislation that was passed by the Nebraska Unicameral in 2014. This guide is informational only and does not guarantee a grant of benefits and is not a definitive reference on Nebraska laws.

# LB 383 Provide for Nebraska Armed Forces Pride Plates

**Sponsor:** Senator Charlie Janssen, District 15

**Committee:** Transportation and Telecommunications

### Timeline:

Introduced on January 18th, 2013 Designated as Senator Janssen Priority Bill on February 20th, 2014 Passed by the Legislature with a vote of 48-0-1 on April 17th, 2014 Signed by Governor Heineman on April 22nd, 2014 Estimated effective date: July 17th, 2014 License plate issue date: January 2nd, 2016

### **Implementing agencies:**

Nebraska Department of Motor Vehicles Nebraska Department of Veterans' Affairs

**Overview:** LB 383 provides for military and veteran license plates issues through the Nebraska Department of Motor Vehicles (DMV) starting January, 2016. Nebraska veterans and military members residing in Nebraska wishing to obtain Armed Forces Pride Plates must first enroll in the Nebraska Veterans' Registry maintained by the Nebraska Department of Veterans' Affairs (NDVA). www.veterans.nebraska.gov

DMV is working to obtain permission to use the logos of the Army, Navy, Air Force, Marine Corps, Coast Guard and Nebraska National Guard. Next, DMV will design a license plate for each logo which will be available in January of 2016.

The plates will be issued for a \$5.00 fee for an alphanumeric plate or \$40.00 for a specialized plate. A portion of the fees will be allocated for operation of the Nebraska Veterans' Cemetery at Alliance.

Additionally, LB 383 strikes the five dollar fee for Ex-POW and Purple Heart license plates.

# LB 588 Change veteran employment preference provisions

Introduced on January 23rd, 2013 Passed by the Legislature with a vote of 44-0-5 on February 13th, 2014 Signed by Governor Heineman on February 18th, 2014 Operative date: January 1st, 2015

### **Implementing agencies:**

State of Nebraska and governmental subdivisions

**Overview:** LB 588 establishes the Veterans Preference Act, updating current statutes pertaining to veterans preference when seeking employment. Under the bill, veterans would be given preference for initial employment in positions with the state or its governmental subdivisions if the veteran is competent to perform the services. Spouses of veterans with a 100% service connected disability are allowed to participate in the Act. The bill requires that notification be sent to veterans that are not hired within 30 days of filling the position.

### LB 737 Change qualifications for county veterans service officers

#### **Implementing agencies:**

Nebraska Department of Veterans' Affairs Nebraska Counties

**Overview:** LB 737 reduces residency requirements for the hiring of new County Veteran Service Officers and for new members of county veteran service committees. LB 737 reduces the five-year residency down to one year of residency and if there are no applicants for the position of county veterans service officer, the one-year residency requirement may be waived.

# LB 740 Provide residency requirements for postsecondary education purposes for veterans and their family members

Introduced on January 9th, 2014 Designated as Senator Crawford Priority Bill on February 4th, 2014 Passed by the Legislature with a vote of 48-0-1 on March 24th, 2014 Signed by Governor Heineman on March 28th, 2014 Estimated effective date: July 17th, 2014

### **Implementing agencies:**

Public colleges and universities in Nebraska

**Overview:** LB 740 grants residency for the purposes of in-state tuition for recently separated veterans, their spouses and dependents. Specifically, veterans who separated from a branch of the Armed Forces of the United States within the past two years are considered resident students, provided the veteran demonstrates intent to become a resident of the state of Nebraska. Intent to become a resident consists of voter registration as well as a Nebraska motor vehicle registration or Nebraska driver's license.

# LB 766 Change tuition assistance program provisions for National Guard members

Introduced on January 9th, 2014 Passed by the Legislature with a vote of 48-0-1 on April 10th, 2014 Signed by Governor Heineman on April 10th, 2014 Estimated effective date: July 17th, 2014

### **Implementing agency:**

Nebraska Military Department

**Overview:** LB766 updated the language of the tuition assistance program as it relates the Nebraska National Guard. LB766 removes dated language from current statutes and also clarifies who is eligible to use the state Tuition Assistance Program.

# LB 806 Change provisions of the Military Code relating to Military Department personnel

Sponsor: Senator Bill Avery, District 28

**<u>Committee</u>**: Government, Military and Veterans Affairs

Introduced on January 10th, 2014 Passed by the Legislature with a vote of 48-0-1 on April 10th, 2014 Signed by Governor Heineman on April 10th, 2014 Estimated effective date: July 17th, 2014

### **Implementing agency:**

Nebraska Military Department

**Overview:** LB 806 makes several technical changes to the Nebraska Military Department statutes including: the elimination of the chief of staff of the Military Department; clarifying the delegation of authority to perform military duties when the Adjutant General is absent; and providing that the deputy adjutant general is not required to take leave or a reduction in salary when performing certain federal duties.

LB 987 Adjust individual income tax brackets for inflation and exempt social security and military retirement benefits from income taxation

# **Committee:** Revenue

### Timeline:

Introduced on January 21st, 2014 Designated as Revenue Committee Priority Bill on February 20th, 2014 Amended with Senator Janssen AM2458 (LB 75) on March 19th, 2014 Passed by the Legislature with a vote of 44-0-5 on May 27th, 2014 Signed by Governor Heineman on April 2nd, 2014 Estimated effective date: July 17th, 2014

# **Implementing agency:**

Nebraska Department of Revenue

**Overview:** LB 987 allows a tax exemption for military retirements for taxable years beginning January 1st, 2015. The exemption applies to retirements that start on or after July 17th, 2012. Military retirees may choose one of the following elections within two calendar years from the date of their retirement:

- 1) The military retiree may elect to exclude forty percent of his or her military retirement benefit income for seven consecutive taxable years beginning with the year in which the election is made, or;
- 2) The military retiree may elect to exclude fifteen percent of his or her military retirement benefit income for all taxable years beginning with the year in which he or she turns sixty-seven years of age.

# LB 1087 Create a homestead exemption for disabled veterans, widows, and widowers

# Timeline:

Introduced on January 22nd, 2014 Designated as Senator Pirsch Priority Bill on February 20th, 2014 Passed by the Legislature with a vote of 48-0-1 on March 31st, 2014 Signed by Governor Heineman on April 2nd, 2014 Operative date: January 1st, 2015

### **Implementing agency:**

Nebraska Department of Revenue with verification of eligibility through the United States Department of Veterans Affairs

**Overview:** LB 1087 provides a homestead exemption for Honorably discharged 100% disabled veterans, unremarried widows and widowers of veteran who died because of a service connected disability or of a veteran whose death on active duty was service connected.
