Tour of Nebraska National Guard Facilities

- I. The aim of this agenda is to comply with the Nebraska Open Meetings Act. Five of six voting members of the Commission on Military and Veteran Affairs have confirmed their attendance of a tour of Nebraska National Guard Facilities, constituting a quorum of the Commission. Additionally, tour participants will receive briefings from members of the Nebraska National Guard and will have the opportunity to ask questions. The tour will start and end at the Nebraska National Guard Joint Force Headquarters Building, 2433 NW 24th St, Lincoln, NE 68524 on Friday, April 13<sup>th</sup> from 8:30 a.m. to 2:30 p.m. The schedule for the tour will include the following two meeting locations and approximate meeting times:

- II. Given the security constraints of Nebraska National Guard facilities and assets, members of the public who desire to attend the meetings referenced above shall be subject to, and must comply with, applicable security policies and procedures for the facilities. A summary of applicable security requirements is provided below.

**Nebraska National Guard and Department of Defense Security Requirements**

*United States military installation security procedures require photo identification, a background check and vehicle inspection in order to gain access onto the installation.*

*You must have a current driver's license, vehicle registration and proof of insurance in your possession to enter, and then drive on, the installation. Individuals not driving on the installation must have another form of valid government identification.*

*Additionally, you will be subject to a background check and vehicle inspection. This background check can take up to 30 minutes so please allow time for that to occur. All vehicles and their contents are subject to inspection upon arrival. Transportation of privately owned weapons on Nebraska Military Department property, except by military personnel or qualified law enforcement officers, is prohibited.*

*Denial to a military installation is at the sole discretion of the installation commander. Once approved to come onto the installation, you will have access only to the approved meeting locations which are located at Joint Force Headquarters, 2433 NW 24th Street, Lincoln, NE 68524 and/or 3010 East Airport Road., Grand Island, NE 68801.*

- III. The Commission's Military Affairs Liaison will enter a report of the tour into the public record during the next meeting of the Commission on Military and Veteran Affairs. Additionally, the Commission will hold a public comment period during the next meeting of the Commission on Military and Veteran Affairs, scheduled for May 23, 2018, where members of the public can ask questions about the tour.
