Norfolk Veterans Home completed our annual United States Department of Veterans Affairs Survey March 03-05, 2020. This survey is conducted annually to ensure that we as a facility are meeting all requirements of a licensed Skilled Nursing Facility in caring for our members. The VA survey team was comprised of a Registered Dietitian, five Registered Nurses, a Fiscal Surveyor and a Life Safety Code expert. I am pleased to report that Norfolk Veterans Home was found to be Deficiency Free, as Forrest Gump would say, A-G-A-I-N. You may recall that during last year's survey, NVH was preparing to evacuate the facility due to a potential levy break caused by flooding in the area. I am not a superstitious person but literally the day our survey was concluded this year, The Office of Geriatrics and Extended Care held conversations and decided to suspend surveys of State Veterans Homes until April 6, 2020. (That date has now been extended), due to the COVID-19 virus and CDC recommendations.

I want to congratulate and SINCERELY THANK each and every teammate for the wonderful care you give our members every day of the year! The surveyors had many complements about our home and the quality of the staff that work here. They could see that our members are well taken care of and each teammate has a role in the success of our home! I can honestly say that the staff at Norfolk Veterans Home provides the highest quality of care and do it better than any group I have ever had the honor of working with.

We, along with every other skilled nursing homes in the state has implemented strict requirements due to the coronavirus pandemic. NVH is only allowing teammates and essential medical personnel to enter the building. Everyone must pass a health screening process every day they report for work. We have changed member dining to allow for distancing members from each other during meals and activities are being conducted in smaller groups without the assistance of our wonderful volunteer base. We are scheduling Skype visits for members so they can stay connected with loved ones via our laptop computers. NDVA Central Office is working very closely with all four State Veterans Homes to keep our members and staff as safe as possible.

I hope everyone gets to celebrate Easter however they can in our "temporary new normal". Please stay safe and we will come out of this stronger and better prepared to handle anything.
